Dear Dr. Pipher,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your April 26, 2021 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at Brown University. According to the information provided, OLAW understands that on February 12, 2021, a lab member failed to euthanize two mice within the approved timeframe and as a result one mouse was found dead and the other humanely euthanized by the Center for Animal Resources and Education (CARE) staff. The study was funded by PHS.

As a corrective measure, the individual was retrained in animal care expectations, going forward the lab member will carbon copy the lab manager and the Principal Investigator (PI) on emails when euthanasia requests are received and the lab instituted a new oversight procedure where the lab manager will follow-up with lab members in response to animal care requests and copy the PI on the messages.

OLAW appreciates the prompt consideration of this matter by Brown University which is consistent with the philosophy of institutional self-regulation. Based on the information provided, OLAW is satisfied that appropriate steps have been taken to investigate this incident and to attempt to prevent recurrence. OLAW expects continuing post-approval monitoring to prevent recurrence of this non-compliance and potential associated animal welfare concern. The Brown University Institutional Animal Care and Use Committee (IACUC), through the Institutional Official (Jill C. Pipher, Ph.D.), is writing to provide OLAW with a final report of the following noncompliance with the *PHS Policy on Humane Care and Use of Laboratory Animals* ("PHS Policy"):

On February 12, 2021, an incident of animal welfare concern occurred wherein a lab member failed to conduct euthanasia of two mice within the timeframe approved by the Center for Animal Resources and Education (CARE) veterinary team. As a result, one mouse was found dead and the other mouse was humanely euthanized by CARE.

The IACUC discussed the incident of animal welfare concern at its April 2, 2021 convened meeting and determined that the lab was responsible for the incident described which meets the criteria for reporting per the NIH NOT-OD-05-034, "*Guidance on Prompt Reporting to OLAW under the PHS Policy on Humane Care and Use of Laboratory Animals.*"

The following corrective actions have taken, or will take, place:

- The individual was retrained in animal care expectations;
- The lab member will cc both the lab manager and the PI when euthanasia requests are received;
- The lab instituted a new oversight procedure where the lab manager will require follow-up from all lab members in response to animal care requests. The PI will be cc'd on these messages.

Brown University is committed to protecting the welfare of animals used in research and appreciates the

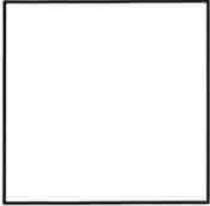
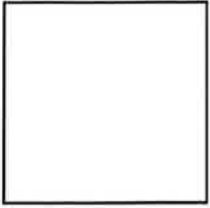
